

# ANFIELD VILLAGE NEWS November 2012

#### **Properties Due For Demolition**

Owners of property on the odd side of Bagnall Street, the even side of Pulford Street and 125-135 Walton Breck Road will be contacted by 20/20 Liverpool, who are the valuers working on behalf of Liverpool City Council, in January 2013. All of the owners of property in the other streets due to be demolished should now have been contacted and tenants should also have been contacted by Housing Options to discuss their rehousing needs.

## **Front Environmental Improvements**

Improvements by the Council to the front of privately owned houses in the areas that are being retained is now underway. This includes all the work required to windows, doors, rainwater goods, roof and brickwork. The work to properties on the even side of Burnand Street and the odd side of Pulford Street is not due to commence until April 2013. Surveys are being undertaken to other properties in the area and will all have been sent out by the middle of December.

# **Anfield Village Refurbishment Programme**



As part of your area's regeneration Your Housing Group opened its door to over 200 visitors to its show home in Gurnall Street in October this year. Over half of the visitors were local residents who were asked to record what they thought about the modernised home. The Show Home, situated in Gurnall Street, was created by knocking two small two bedroom houses into one to create a spacious three bedroom home with an open plan living space, upstairs bathroom and a garden with a seating area. A similar refurbished home has been completed in Saker Street and is now let to a local resident.

The pilot property was completed as part of a public consultation process to show what these properties could look like when converted. Residents' comments have been taken on board who visited the show home and this will influence future plans.

Your Housing Group are in the process of seeking planning permission on the first phase of refurbishments which have identified 24 dwellings to be improved with a mix of house types being created to meet demand from within the area.

Your Housing Group have contacted its tenants and recorded interest of residents who may want to move to a refurbished home in the Village and this information is being used when looking at what properties can be refurbished.

There is also an opportunity for any resident whose home is part of the clearance programme to be allocated a refurbished property and visiting staff are recording these interests when sale's have been agreed.





## The Parks Phase 3 (Keepmoat new build)

Your Housing Group have allocated properties on The Parks Phase 3 to residents from the clearance area, based on their priority within Anfield Village and if they have an agreed sale proceeding as either a home owner, private landlord tenant or a Your Housing Group tenant.

This has been a very exciting time for a number of residents who have needed more suitable level access accommodation (bungalows), as they have been into Your Housing Group's local office to pick their new home location and colour choices for their bathrooms and kitchens.

To date only 13 out of the initial 42 homes, which Keepmoat are building and will be completed by the end of March 2013, have been allocated. This means that there are still opportunities for residents who are in the process of agreeing sales to be considered for the new homes. If this applies to you please notify your visiting officer.
